ALL STUDENTS WHO ARE GETTING A LIBRARY BOOK MUST USE A BOOK LOOKER! 3. Students who didn't return a book (forgetters) should go straight to the circulation desk to check their card. Then, they may read a magazine at their table. After book exchange, all students should read at their table. Sharing books quietly is acceptable as well. 4. Flicker lights for attention, and dismiss students by color table to line up at the door when they are reasonably quiet and ready.

The Foundation of Common Core in Elementary Libraries
